

Sea Mist Pet Policy

- Sea Mist welcomes well-behaved, small to medium-sized dogs and cats not to exceed 100 pounds each. Exotic pets are not permitted. Management reserves the right to disallow any pet.
- No more than two pets per reservation.
- All pets brought to Sea Mist must be in good health and must be current with all recommended shots and vaccines.
- Pet friendly accommodations are available in select buildings on a first come-first serve basis:
 - Sandcastle Building
 - Guest Villa
 - Chestnut Cottage
 - Guest House
 - Sand Fiddler Suites
 - Sandy Knoll Building
 - Palms Building
 - Yaupon 2-story Suites
 - Sandlapper Building
 - Suites & Cottages in the Family Village

Pets are not allowed in any Sea Mist building other than those guest-rooms specifically identified as "pet-friendly."

- When booking your reservation, you must notify the reservations agent that you will be bringing your pet(s). Failure to do so may result in a pet friendly room not being available when you arrive and your pet not being permitted on Sea Mist property.

- **There is a pet fee of \$50 per pet per stay. Extended Stay reservations will incur a \$100 fee. This fee is not refundable. Additional charges will be imposed if a pet causes damage to Sea Mist property or if extra cleaning is required upon departure.**
- Daily housekeeping service is not available to guests traveling with pets. Supplies will be provided upon request.
- **While on Sea Mist property:**
 - All pets must be both well-behaved and people-friendly.
 - You must maintain complete control of your pet at all times. Pets must be on a leash or otherwise confined whenever outside your room.
 - Pets must be confined in a crate when left alone in your room or at any time that Sea Mist staff is in your room (for instance, housekeeping or maintenance).
 - Pets are not permitted on Sea Mist elevators.
 - Pets are not allowed in the pools, jacuzzis or water-parks or their decks.
 - You must clean up after your pet, both in your room and on Sea Mist grounds. Please bring to the hotel any supplies you will need for removing your pet's waste (for instance, a litter box or pooper scooper). Sea Mist does not provide these supplies.
- **Sea Mist reserves the right to have any pet immediately removed from Sea Mist property**

The City of Myrtle Beach Leash Law

- Dogs in public must be on a hand held leash seven feet or shorter at all times.
- No animals are allowed on the beach or Ocean Boulevard between 21st Avenue North to 13th Avenue South of Myrtle Beach during any time. (Beach access at 13th Avenue South and beyond is very convenient at Sea Mist and allows easy access to the beach for you and your pet.)
- Pets cannot be on the beach from 10 AM - 5 PM from May 1st through Labor Day, but are allowed before and after those times. Owners must pick up after their pet.
- Leashed pets are allowed on the Boardwalk from 5 AM - 10 AM only during the May- Labor Day window.

The City of Myrtle Beach has an off-leash dog park where owners may let their pets run and play. Barc Parc South is off Mallard Lake Drive near Grand Park and The Market Common (3 miles south of Sea Mist). The park covers 14 acres, includes a large lake, and is fully fenced. The park is open from sun up to sun down. Dogs must meet height requirements, which are posted on the entrance gates. Rules for behavior also are posted, and owners are responsible for picking up after their pets and properly disposing of the waste. Handy picker-uppers are provided.
